 - O Students wrote to the blackriveraoc@gmail.com email with comments & concerns about the health of the Black River. Kate will take lead to arrange a classroom visit with support from Don R., Patti D., & Bruce K.

& Black River Watershed Updates

- County updates:
 - Scott Pozna retiring from LCPH. Motion for Mike Jindra (also LCPH) to take his place on the committee. Motion by Steve Holland / Second by Kate Golden. No objections. Mike Jindra to replace Scott Pozna's position on committee, effective January 1, 2025.
 - Mike Jindra currently manages the Lorain County Home Sewage Treatment System program for LCPH. Mike previously managed the residential mosquito project. He has wastewater & chemical plant experience. He was also a professional naturalist with a degree in Environmental Education. Welcome aboard, Mike!
 - Lorain County Board of Commissioners approved the Kelner Ditch project. The ditch petition process received no objections & is now going out for bid. The project will include removal of log jams & clogged culverts along the five mile stretch.
 - City of Lorain and Lorain County Metro Parks will be looking into identifying future monies (NatureWorks) for the 60 acre Gerber Wetlands project in Eaton Township in late 2025/early 2026.

• City/Township updates:

- O <u>City of Lorain</u>: Nine days before the geopools were to begin accepting dredged material from the Black River, straight line winds damaged four of the eight geopools. However, dredging still began on schedule by USACE, utilizing the four undamaged structures. Approximately 61,000 cubic yards of material was received into the geopools & the dewatering process is currently underway. The removal of solids from the geopools will take place in February & March of 2025.
 - The four damaged pools will not be used as the structural integrity cannot be guaranteed. An insurance claim was filed & four new pools will be purchased & installed.
 - ▶ USACE will NOT be using the geopools next year (2025).
 - The discharged water back into the Black River had very low turbidity, indicating that the geopool structures and discharge process were very effective.
- <u>City of Lorain</u>: Money received for waterfront development at the Hot Waters location for new docks. Construction expected to begin in 2025.

Ohio AOC Updates

- Hannah Boesinger gave birth on August 19th to healthy baby boy named Miles!
- From Kris Patterson (OLEC): "The Ohio EPA director has not reached out to schedule her boat tour and I imagine that boating season is done for this year so maybe next year sometime."
 - O "Ohio Lake Erie Commission (OLEC) is working with US EPA and some of our federal partners to secure some funding for next year for USFWS to take a look at the benthos in the lacustuary zones of the rivers so we can figure out why those areas aren't as close to meeting the BUI removal targets as riverine areas or if the target needs to be adjusted for lacustuary areas. We should know before the next AOC meeting if USFWS will be out in the field next year."
 - Amber Bellamy (USFWS) responded: "USFWS may have to rethink the criteria. Is there a better metric for measuring benthos in lacustuary areas compared to riverine areas? What does a healthy Ohio lacustuary look like?"
 - O KP, cont'd: "I don't have any dates picked out, but I will be planning an Ohio AOC Summit (like Lynn [Garrity] used to) for sometime this winter, probably February or early March. I may reach out for some assistance since Lorain seems to be a great central location for meetings like that."
 - Committee members discussed Henry's Barn (LCMP) as a possible option.
- From Carla Rosenfeld USEPA: "The only EPA update is that we had another AOC delisted –Rochester Embankment in New York state in October 2024
